**Terms and Conditions**

- 1) Inquiry/NIQ No. Must in variably be given at the top of the envelopes. Envelopes without indication will not be entertained.
- 2) Tax will be paid extra, if applicable provided it is made clear in the quotations that VAT/CST/GST/SERVICE TAX @%will be charged extra, otherwise it will be presumed that VAT/CST/GST/SERVICE TAX are not to be paid extra.
- 3) Unsealed quotation will be rejected.
- 4) Validity of the quotation should be for a minimum period of 120 days.
- 5) The quotation must be addressed to the Medical Superintendent, Rajindra Hospital, Patiala.
- 6) Service will have to provide immediately.
- 7) The Institute reserve the right to reject the CMC contract if the service is not found in accordance with the PO.
- 8) Quotations must be sent by registered post/speed Post/Courier/ by hand at receipt Branch Of Medical Superintendent, Rajindra Hospital, Patiala with in working hours(9.am to5 pm).
- 9) C.M.C Rate will be fixed for one year from the date of PO. If work found satisfactory the rate contract of C.M.C may be extended for one more year with same rates.
- 10) Service provider will have to keep working all AC during CMC period.
- 11) No Extra payment/items and man power will be given/provided by this institution to service provider.
- 12) The firm shall depute experienced engineer who shall carry out preventive maintenance at least once a month. During these visits cassette ac and ductable ac shall be thoroughly checked.
- 13) Emergency calls must be attended as and when required.
- 14) Complaint must be attended in the 24hrs.of the intimation otherwise department will impose penalty at the rate of 0.5%per month of the contract value.
- 15) Material required in execution of the work and required to be stored in our premises shall Entirely be at firm's risk and consequence.
- 16) All spare parts will be covered under CMC. External and internal filters should be changes once in year.
- 17) 50% payment of maintenance contract will be released after every six monthly on the basis of satisfactory working report of AC from the concerned department.
- 18) Within 15 days after receipt of acceptance letter, bidder shall be required to pay performance security deposit in the shape of Bank Guarantee of 10% of the total value of supply order without taxes as per performance security,. The performance security shall be denominated in Indian Rupees as unconditional Bank Guarantee issued by a National / Scheduled Bank located in India. This performance security amount will be refunded after satisfactory completion of CMC period.
- 19) The prospective bidders are advised to visit the site before submitting their bids.
- 20) Contract will be awarded to L-1 on the basis of totality in rates.
